Public Authority Section 75 Equality Duties Summary of Annual Progress Reports 2017-18

Equality Commission for Northern Ireland February 2019

Introduction

Most public authorities operating in Northern Ireland are required to submit an equality scheme to the Equality Commission¹. This is a statement of the public authority's commitment to fulfilling its Section 75 statutory duties and the arrangements for ensuring that these duties are complied with.

Each equality scheme must outline the public authority's arrangements for:

- assessing its compliance with Section 75 statutory duties and for consulting on matters relevant to the duties
- assessing and consulting on the likely impact of policies adopted or proposed to be adopted by the authority on the promotion of equality of opportunity
- monitoring any adverse impact of policies adopted on the promotion of equality of opportunity
- publishing the results of such assessments
- training their staff
- ensuring and assessing public access to information and services provided by the public authority.

The Commission recommends that public authorities include a commitment to conducting an annual review of progress on the implementation of their equality scheme, including progress on the delivery of actions to promote equality of opportunity and good relations. A copy of the annual progress report template is at appendix 2.

Summary of Annual Progress Reports 2017-2018

158 public authorities were designated as at **31 March 2018**, of which 128 were due to submit an annual progress report. In total 127 annual progress reports were submitted to the Commission, the majority of which were received by the end of August 2018. The Commission did however include any annual progress reports received up to February 2019.

Table 1 summarises the 158 public authorities into whether or not they were due to submit an annual progress report. The full list of the 158 designated public authorities (31 March 2018) is included in Appendix 3.

This report compiles the quantitative information provided by 115 public authorities in their individual annual progress reports for the period 2017 - 2018. Twelve public authorities did not use the Commissions Annual Progress Report template. Data from these annual progress reports have been included were possible.

The individual progress reports provide more detailed information on the progress of each public authority and should be available on public authority websites.

Section 1: Equality and good relations outcomes, impacts and good practice

Question: Has the application of the equality scheme commitments resulted in any changes to policy, practice, procedures and/or service delivery areas?

38% (N=44) of public authorities reported that the application of equality scheme commitments had resulted in **changes** to policy, practice, procedures and/or service delivery areas; 53% (N=61) reported that it had led to no changes; and 5% (N=6) reported that the question was not applicable.

Question: What aspect of the equality scheme prompted or led to the change(s)?²

50% (N=20 of 44) cited **'other' reasons**;

45% (N=20 of 44) reported that it was as a result of the organisation's **screening of a policy**;

36% (N=16 of 44) reported that it was as a result of analysis from **monitoring impact**;

39% (N=17 of 44) reported that the aspect of the equality scheme leading to change was a result of **changes to access to information and services**; and

23% (N=10 of 44) reported that it was as a result of what was identified through the **EQIA** and consultation exercise.

Section 2: Progress on equality scheme commitments and action plans/measures

Question: Were the Section 75 statutory duties integrated within job descriptions?

37% (N=42) of public authorities reported that the Section 75 statutory duties were integrated within job descriptions organisation wide; 36% (N=41) of public authorities reported that the Section 75 statutory duties were integrated within job descriptions in some departments/jobs

15% (N=17) of public authorities reported that this action is scheduled for later or had already been done. 9% (N=10) reported that this question was not applicable. 4% (N=5) reported that the action was not an equality scheme commitment.

Question: Were the Section 75 statutory duties integrated within performance plans?

41% (N=47) of public authorities reported that the duties had been integrated within performance plans **organisation wide**; 33% (N=38) reported that the Section 75 statutory duties had been integrated within performance plans in **some departments/jobs.**

11% (N=13) of public authorities reported that this action is **scheduled for later** or had already been done, while 9% (N=10) reported that this action is not an equality scheme commitment. 5% (N=6) reported that this question was **not applicable** and 1% (N=1) gave **no answer**.

Question: Were objectives/ targets/ performance measures relating to the Section 75 statutory duties integrated into corporate plans, strategic planning and/or operational business plans?³

63% (N=73 of 115) public authorities reported that objectives/ targets/ performance measures relating to the Section 75 statutory duties were integrated through organisation wide **annual business planning**;

31% (N=36 of 115) reported that it was integrated through work to prepare or develop the **new corporate plan**; 17% (N=20 of 115) reported that it was integrated in **some departments/jobs**.

23% (N=26 of 115) public authorities reported that objectives/ targets/ performance measures were **already mainstreamed** through the organisation's ongoing corporate plan;

4% (N=5 of 115) reported that integration did not coincide with the organisational planning cycle.

Equality action plans/measures

Question: In your equality action plan indicate the number of actions completed, ongoing, expected to commence:

Public authorities reported that during the 2017-18 reporting period 732 of equality action plan/measures had been **completed**; 791 actions were **ongoing** and 139 actions were **yet to commence**.

Question: In reviewing progress on the equality action plan/action measures, the following have been identified:⁵

81% (N=93 of 115) public authorities reported that they were continuing action(s), **to progress the next stage** addressing the known inequality;

20% (N=23 of 115) reported action(s) to address newly identified inequalities/recently prioritised inequalities;

19% (N=22 of 115) reported they were progressing action(s) to address the known inequality **in a different way**; and

24% (N=28 of 115) reported that measures to address a prioritised inequality **had been completed**.

Arrangements for consulting

Question: Following the initial notification of consultations, a targeted approach was taken – and consultation with those for whom the issue was of particular relevance.

48% (N=55) of public authorities reported that **following the initial notification** of consultations a targeted approach was taken, and consultation with those for whom the issue was of particular relevance occurred **all the time**; 32% (N=37) reported that this process **occurred sometimes**; 11% (N=13) reported that this **never happened**; and 9% (N=10) gave **no answer**.

Question: Which consultation methods were most frequently used by consultees?⁶

73% (N=92 of 126) of public authorities reported that **written documents** with the opportunity to comment in writing were the most frequently used consultation method;

69% (N=87 of 126) reported face to face meetings;

47% (N=59 of 126) reported questionnaires

46% (N=58 of 126) reported information/notification **by email** with an opportunity to opt in/out;

48% (N=61 of 126) reported focus groups;

25% (N= 31 of 126) of public authorities reported that **telephone consultations** were the most frequent method of consultation used; and

6% (N=8 of 126) reported that **internet discussions** were the most frequent method used.

13% (N=16 of 126) of public authorities reported that they used 'other' methods for consultation.

Question: Were any awareness-raising activities for consultees undertaken, on the commitments in the equality scheme?

33% (N=42) of public authorities reported that they had carried out awareness raising activities for consultees **on the commitments in the equality scheme**, 50% (N=63) of public authorities carried out **no awareness raising activities**. 13% (N=17) of public authorities reported that this **action was not applicable**, 3% (N=4) gave **no answer**.

Question: Was the consultation list reviewed?

68% (N=86) of public authorities **reviewed** the consultation list during 2017-18, 19% (N=24) of public authorities **did not review**. 12% (N=15) of public authorities indicated that this was **not an equality scheme commitment**. 1% (N=1) gave **no answer**.

Arrangements for assessing and consulting on the likely impact of policies

Question: Please provide the number of policies screened (as recorded in screening reports).

One hundred and twenty six public authorities reported that they had **screened 1292 policies** during the year (as recorded in screening reports).

Question: Please provide the number of assessments that were consulted upon during 2017-18

94% (N=289) of policy consultations were **conducted with the screening assessment** present; 5% (N=15) policy consultations were **conducted with an equality impact assessment**; and 1% (N=4) policy consultations were **conducted for an EQIA alone**.

Question: Were any screening decisions (or equivalent initial assessments of relevance) reviewed following concerns raised by consultees?

9% (N=11) of public authorities reported that screening decisions were **reviewed following concerns** raised by consultees; 36% (N=45) of public authorities reported that **no concerns were raised** by consultees; 17% (N=21) reported **no screening decisions** were reviewed and 38% (N=48) reported that this question was **not applicable**. 1% (N=1) gave **no answer**.

Arrangements for publishing the results of assessments

Question: Following decisions on a policy, were the results of any EQIAs published?

3% (N=4) of public authorities reported that the results of EQIAs were published during the 2017-18 reporting period; 24% (N=30) of public authorities reported that **no results of EQIAs were published**; and 73% (N=92) of public authorities reported this question was **not applicable**.

Arrangements for monitoring and publishing the results of monitoring

Question: From the equality scheme monitoring arrangements, was there an audit of existing information systems?

20% (N=25) of public authorities **carried out an audit** of existing information systems during the 2017-18 period; 18% (N=23) reported that the **audit was scheduled** to take place at a later date. 36% (N=45) of public authorities had **already carried out an audit**; and 25% (N=32) reported that this question was **not applicable** and 1% (N=1) gave **no answer**.

Appendix 1. Meaning of Public Authority for the purposes of the Public Sector Equality Duties

- 75(3) In this section "public authority" means—
- (a) any department, corporation or body listed in Schedule 2 to the Parliamentary Commissioner Act 1967 (departments, corporations and bodies subject to investigation) and designated for the purposes of this section by order made by the Secretary of State;
- (b) any authority (other than the Equality Commission, the board of governors of a grantaided school, the Comptroller and Auditor General, a general health care provider or an independent provider of health and social care) listed in Schedule 3 to the Public Services Ombudsman Act (Northern Ireland) 2016 (listed authorities);
- (cc) ... the Chief Constable of the Police Service of Northern Ireland and the Police Ombudsman for Northern Ireland;
- (cd) the Director of Public Prosecutions for Northern Ireland;
- (ce)
- (cf)
- (d) any other person designated for the purposes of this section by order made by the Secretary of State.
- (3A) An order under subsection (3)(a) or (d) may provide that the designated department, corporation, body or other person –
- (a) is not subject to, or is only subject to, specified obligations under subsection (1) or (2), or
- (b) is not subject to, or is only subject to, specified obligations under subsection (1) or (2)
 - i. when exercising a specified function, or
 - ii. when exercising a specified function in specified circumstances or for specified purposes
- (3B) In subsection (3A) "specified" means specified in the order. 13
